The theme of this year's **ISSF** aims to provide relevant knowledge and a better understanding of social banking and financial services from both the *maqasid* and operational perspectives. Therefore, **ISSF2019** provides a high-level platform to discuss features, models and fundamental differences between Islamic social banks and other social banks. ISSF2019 aims to provide a platform for Shari'ah experts, regulators, industry practitioners and all involved in Islamic finance across the globe to share their knowledge, experience and expertise to strengthen and further develop Islamic banking and finance internationally.
